

## **Standard Terms and Conditions of Sale**

1. A quote will be given to the client upon request.
2. Quotations remain valid for a period of 14 (fourteen) business days.
3. A 10% (ten) deposit of the total quotation will secure the sale (refunds of deposits are subject to T&Cs)
4. A 40 % (forty) deposit of the total quotation is payable on the date of acceptance of the quotation (refunds of deposits are subject to T&Cs).
5. 25 % (twenty-five) is payable at the time that assembly starts.
6. The remaining 25% (twenty-five) of the total money due is payable on the day the trailer is collected or when it is delivered.
7. Timelines are indicated as a guideline only and Bushwakka Africa cannot be held liable for any overruns as a consequence of operational issues including supply chain challenges, outside their control.
8. Bushwakka Africa reserves the right to retain a portion of the money paid as a fair cancellation fee for any costs spent in the event that a transaction is canceled by the customer prior to completion and/or delivery for any reason.
9. Bushwakka Africa retains the right to use photos of trailers that have been outfitted with branding and/or equipment for promotional reasons.
10. Any deliberate misuse of the product where it is utilized outside of its intended use is not covered by warranty.
11. The client also holds Bushwakka Africa harmless and indemnifies Bushwakka Africa in respect of any and all liability that may arise as a consequence of any licensing and/or patent issues that may apply in respect of the specification, design and manufacturing of the product.
12. Until the whole invoiced amount is paid, Bushwakka Africa retains ownership of the items, which will not be released. When something is taken without being fully paid for, it is considered theft, and criminal charges may be filed.
13. The client accepts that due to the manual manufacturing process small scratches and dents may occur on body work, Bushwakka Africa will however endeavor to ensure that this is kept to a bare minimum, should it occur.

- 14. Management and/or the business will not be held responsible or liable for loss or damage to any goods or equipment not collected after payment is made, or any goods stored or left in our factory or facilities for any reason whatsoever.
- 15. Handover and collection of the finished products will be at Bushwakka Africa factory, or our nominated agent's premises. Delivery can be arranged at a normal fee.
- 16. Bushwakka Africa will not be held liable for any damage that may occur during shipping and exporting. Bushwakka Africa will ensure to its best abilities to pack and load to avoid any damage.
